

RESOLUTIONS TO GRIEVANCES

PREAMBLE

The reality of the current state of our nation is, we are in a complete freefall, and if we continue down our current course, we will inevitably encounter a much worse scenario. If we, collectively as a country, address these issues now, as opposed to putting them off for the next generation, we can make real, true change. While all the grievances listed are very real issues, we do not have nor claim to have, every answer to these problems. If we choose to ignore these issues, we are exposing our country, homes, and families to a real threat from both domestic and international threats. This statement is not intended to frighten you, but rather give a real depiction of the dire situation that every American is in right now.

We can choose to lay low and ignore these issues, but they will come back to haunt us, or even more frightening, haunt our children and their children, leaving them in a position that will leave their livelihood in question from foreign government threats, lack of goods, lack of services, being under-educated, malnutrition and more. Unfortunately, the leadership of this country has never been with the American people at the forefront of their minds, but rather greed.

We are positioned right now to make a real change that will allow every American to have a real voice. In making these changes we make America a safer and better place for all Americans to live from sea to shining sea. Collectively, we can make a change, but not without your help. We hope you read the grievances and resolutions with an open mind and understand we all need to do our part to make this America a place we can ALL be proud to call home. Alone we are weak but united we are strong. Let us unite and be the strength America needs now putting on full display to future generations what America can be when we work together. Better still, let us be the America that the world thought we were and the America the world can truly look up to and aspire to be once again.

Throughout this document, for nearly every grievance, we wish to establish boards of educated and knowledgeable people from a variety of fields. These boards will be established by an interim executive branch of nine people who will be tasked with finding people for each of the boards and carrying out the action items below. The interim executive branch committee members have not been established and may remain anonymous until ready to assume power once all current elected officials have resigned or been removed from their elected posts.

RESOLUTIONS

We find these Facts to be true against the American people:

Natural Rights (Inalienable Rights)

Assembly

“We the people feel we should be able to assemble and peacefully protest without being abused by the police, national guard, politicians, the media at the direction of the politicians and wealthy elite, and the active-duty military.”

SUMMARY:

- Any American has the right to assemble in a peaceful manner
- The active-duty military should never have a purpose for disturbing a peaceful assembly on American soil

FULL RESOLUTION: We the Robin Hood Revolution feel that the right to assembly is outlined properly and people have used it throughout the history of the United States of America to accomplish their goals. We do not want this to change in any way with the exception that under no circumstance will the active-duty military be allowed to be used on domestic soil against its own people. The military is for fighting foreign enemies and protecting the people, not to use against the American people.

Free and Accountable Press

“We the people find that while we need a free and accountable press, what we are operating now is nothing more than a propaganda machine for the wealthy elite and the politicians. We are using a system that shows no true accountability as we can see daily stories in which people's “word” is taken and used to drive the story without any regard as to who the source is. We use networks and the press to move and make agendas that support and help the wealthy elite and politicians. We see daily that most stories have no basis of truth and are created to make a movement for big corporations, the wealthy elite, and corrupt politicians. Today's news is nothing more than advertising for the wealthy elite as most of the news is baseless and untrue. We need a system where people are held accountable and when this cannot happen there needs to be repercussions for misleading or telling half-truths. We need a press that is held to the same standards as people in any other industry tasked with telling the truth and revealing information to the American people.”

SUMMARY:

- Freedom of speech is an individual right, not a corporate right
- Press has become a propaganda machine
- Americans deserve accurate, non-manipulated information
- Proposed three-strike system to maintain integrity in the press

- The press has become weaponized by the wealthy elite and corrupt politicians to make more money through propaganda

FULL RESOLUTION: The Robin Hood Revolution feels that freedom of speech is vital to the success of our democracy. Freedom of speech and freedom of the press does not give the right for corporate America and the government to manipulate our belief systems because it does not coincide with their agenda.

The American press has become no more than a propaganda machine providing campaign advertising for the elected officials on behalf of the wealthy elite Americans. That must end here and now.

We need to establish a board of nine people selected by the interim executive branch that will oversee the reform, and present to the people, a system that is free of being manipulated, first by actual media owners themselves. If you look at the three non-network news stations, any recent poll will show that more than 50% of the stories produced are false, making it clear and obvious that they are being manipulated by our politicians and the wealthy elite who buy advertisements on their station. The board will establish an accountability system using the resources of the IRS such as former buildings and staff from the IRS and engage an accountability system that holds these networks and their journalists accountable. The extent and parameters of the accountability system will be laid out for the American people with different options, and an outline will be needed for the American people to vote on this resolution.

If the American people are not given clear, accurate information and continue to function off tainted knowledge from political, corporate, or personal agendas, they can never have true freedom of speech to voice their opinion and a large factor in this issue are Super PACs. A large amount of this misguided information will go away by eliminating the Super PACs. Additionally, we propose eliminating gerrymandering and eliminating corporate donations. We have all been told the American people have an equal vote, however, nowhere does it state that every company, corporation, or the government has an equal vote.

We do want to be fair; many journalists have tried to bring the truth to the American people only to be suppressed by the wealthy elites, networks, and politicians. We propose a three-strike system in the accountability program. However, if a journalist repeatedly files false and misguided information, acting as a propaganda machine for any movement, including our own, they will be given notices, once issued the third strike, they would lose their license to practice as press. The people that hold the fate of these journalists, whether they lied, are pursuing propaganda, or any other issue, this will come back to the American people to vote on. These voting measures will be done based on the demographic in question. If a journalist is local, it will be the local people that vote. If it is a state journalist or national journalist, those demographics will dictate whether they remain journalists or not.

The network broadcast journalist will have to be held accountable from this same system and if they are allowed to manipulate information on true information to be broadcasted, they are in direct violations of free speech and they will be fined and reprimanded accordingly. Without good information, good decisions cannot be made. One detrimental issue we have in America right now is when we declare to have breaking news only to find it is based around unnamed sources. Unfortunately, with so much technology readily available at our fingertips, millions of American people are not given a trial by a jury of their peers, they're given a trial by public opinion which tends to be based off which network can stream the most catchy punch line, and people are crucified before ever having a fair day in court. This is unconstitutional and unjust to everyone. As we have seen in a recent Supreme Court Justice confirmation, unnamed and unreliable sources were used to create a media fury that brought injustice to a lifetime of hard work and questioned a reputation unnecessarily. These sources did not even have enough dignity to put their name on it and later they did admit that they were lying, these people tried to benefit from propaganda against this individual. If somebody falsely proclaims information that could be hurtful to someone else, the court needs to intervene, and these parties are held accountable for the injustices they caused. We the Robin Hood Revolution believe that if somebody slanders another person it impacts a person's reputation which, in the legal field, is very hard to build. These people need to be held criminally accountable and charged with a misdemeanor that holds them accountable for the lies that they projected onto somebody else.

Gun Control

“We the people have failed to see the real issue when it comes to bearing arms in this country. A country and its people should always be afforded the right to bear arms for self-protection and the protection of our loved ones and our properties. Our country has used these instances of violence to redirect conversations that should be happening about security and safety. The schools are so under-budgeted because of the wealthy elite using loopholes and not paying taxes and if they paid their share, we could keep our kids safe. Additionally, the media on direction from the wealthy elite love these tragedies as it allows for them to be more profitable until they can brush this topic aside and wait until the tragedy strikes to incur more monies. Every person should have the right to bear arms, as needed, in the event a government tries to suppress and conquer its people until they reach a point of loss and lose the inability to defend themselves. Our right to bear arms has already been established in this country, it is impossible at this time to reclaim these arms, and should this happen, it will instigate a civil war between our government and its people.”

SUMMARY:

- Americans have the right to bear arms and that right should remain
- Confiscating guns will be impossible and a waste of resources
- We need to train for better defense of schools rather than attempting to control guns already available in the public and private arenas

FULL RESOLUTION: Regarding gun control, many laws already are in effect. The Second Amendment is clear that everyone has the right to bear arms and that is an American right that

needs to continue. The reason we feel it is not effective to try to change the laws is that so many weapons, of all kinds, are already out on the streets and to try to retain those or limit them would not be effective in any way. We feel it is a top priority to keep our kids safe and secure. We cannot control the mentally ill people who go to a school and take the life of our educators and children, this risk will always remain. We can control being more proactive and providing more training and security to those who protect and serve at these establishments. We can control this by doing our due diligence on these protectors, doing proper background checks to verify their qualifications for this role, and providing them with adequate funding and adequate firearms to defend our schools and our children. By closing tax loops and forcing the wealthy elite to pay their fair share, there will be plenty of funds to accomplish this training and station every school with multiple officers and the equipment needed to keep schools safe. We are beyond the point of trying to control firearms, it is time to defend our schools with what is needed, instead of arguing about what should have been done.

Marriage

“We the people of the Robin Hood Revolution hereby declare that marriage has become a politically relevant topic and weapon for politicians. The only reason we can see that the government is involved in the marriage process is to issue marriage licenses. We understand taxes can be viewed differently by filing as married, single, or other manners. However, the topic of marriage is now being used as propaganda for tearing down opposing political parties through the use of cheap catchphrases, to create divisions and factions within the communities and these harsh comments and unnecessary realities trickle to the home front causing problems for our families. Our governments has taken this topic, among many others, to create argument points against political opponents instead of focusing on what we all have in common, and have caused unnecessary harm to families for the right to hold a political office to further lie and steal to the people. This must stop.”

SUMMARY:

- The government should have no say in the sacred relationship of marriage
- Any two people may be married

FULL RESOLUTION: We at the Robin Hood Revolution resolve that the government should have no role in any way shape or form with marriage. Marriage, a legally binding contract, should in no way be dictated by the government or allow the government to force its opinion on our rights or in our sacred relationships. Marriage as it should be is a sacred relationship between two people and in religious cases, with their higher power, but it has become a mockery in our society with over half of marriages ending. If citizens wish to engage in marriage through their religious beliefs, this is their right, the United States government should not be involved. If the couple would like to assume the other's name, this can be accomplished as a name change through the legal system and the government needs to honor the request of those people. However, the government should never have a role in saying who can be married or who cannot, regarding sex, sexual preference, race, or any fabricated reason to create factions.

Privacy

“We the people are living in a time where a search and seizure, no longer has the same meaning. This is necessary as the government has allowed for the technologies of today to blindly steal our information from every electronic device we use. We no longer are afforded the privacy of using a device without the government, big tech businesses, and the wealthy elite to steal and profiteer from our most private and personal information through the unlawful forcing of terms and agreements in our day to day lives.”

SUMMARY:

- Government has too much accessibility to private citizens information without warrants
- Information is being sold to the highest bidder
- Repurpose IRS and use its resources for monitoring government involvement on technology platforms

FULL RESOLUTION: The intelligence agencies in our country and the leading tech firms of our country have been pirating our information without our knowledge for years. It is considerably advanced, and it is got much worse as time has gone on. It has gotten to the point that every single keystroke on your computer, every phone conversation you have, is available to the highest bidder.

We are suggesting that a law be passed that nobody's private information can be accessed without a warrant from the court and no personal information can ever be kept or sold from these private tech firms, ensuring that the American people's information is not being sold off without their knowledge. We understand that agreements and waivers are signed beforehand in a consent form but we feel that the people are being fraudulently induced by language which is so advanced and written in such a way that it manipulates the American people to the point where they give up and just comply.

We suggest using assets that the IRS already have and form a new regulating firm that's sole purpose is to ensure that these big private tech companies and the government are not utilizing our information without a warrant or written approval. With an IRS restructuring, we will have many resources available in the way of staffing, buildings, office space, and office equipment which could easily be converted to regulate this issue and protect the privacy of the people.

Freedom of Religion

“We the people of the Robin Hood Revolution are with Christian backgrounds. We believe that in any government, Freedom of Religion is a foundational piece. As Christians we show our faith by trying to follow Mark 12:30-31, “Love the Lord your God with all your heart, with all your soul, with all your mind, and with all your strength. The second is this, love your neighbor as yourself, there's no commandment greater than these.” We feel that to love your neighbor as yourself is to give them the freedom to worship whomever they choose to worship and respect any traditions that come along with that. The only issue that we have is when people turn to

violence to try and push their religious views on to other people. We want everyone to worship how they choose.”

SUMMARY:

- All persons have the right to practice whichever religion they choose so long as they do not inflict harm to another party

FULL RESOLUTION: The Robin Hood Revolution believes that the current laws allow for Freedom of Religion except for political propaganda being pushed on people at different times. Freedom of Religion is a human right and every person must be able to worship the way they feel their religious beliefs require them to whether that being wearing a khimar, not standing for the Pledge of Allegiance or any other regard they feel is needed. However, where the government must and will engage is if people are using violence to stop others from worshipping in their methods or to try to force any religious beliefs onto other people. Otherwise, the government needs to stay out of religion, and religion needs to stay out of government, as they are both pillars of any community.

Freedom of Speech

“We as the people have failed to allow true freedom of speech for all people. From the beginning, we have kept women and people of color from establishing a true vote for freedom of speech. To this day, we continue to suppress the voice of the people through Gerrymandering, through Super PACs, through delegates, through unions, and through social media to ensure that the politicians kept in power are those who are most able to keep the wealthy elite ruling this country, and those who are without, kept to the bottom without a way to voice an opinion or make a change.”

SUMMARY:

- All journalists are required to get a license to practice journalism
- Restructure of the voting system through a pure democracy software system
- Donation limits of \$50 to any elected officials, no corporations
- All federally elected officials to resign immediately

FULL RESOLUTION: To maintain freedom of speech, the information presented needs to be accurate. Today, free press, which is a foundational block in our democracy and freedom, is being presented to the American people in a form which has been construed and twisted. The press is being used for propaganda to spread lies, push personal agendas, and silence the voice of the American people. The Robin Hood Revolution requests that the interim executive branch creates an accountability organization that would require a journalist to obtain a license. This license would signify that journalists are going to be held to a standard like that of doctors or lawyers. We need to have an accountability system holding the country's press accountable for the materials they present to the public. The first step to freedom of speech is taking away information that is harmful and misleading.

The next step to re-establishing the American people's freedom of speech is to reorganize and restructure the voting system on both federal and state levels. The first step to this reorganization is to turn our voting system into a pure democracy by taking a software system that already exists and using that system during our election seasons. The software would need to be encrypted for security reasons.

The next step to re-establishing the American people's voice is to regulate donations. Donations can be made by individuals with set donation limits per person. For years, political figures have been getting around regulations by forming Super PACs which carry with them unlimited resources. The wealthy elite buy advertisements on behalf of whichever candidate they choose to most benefit their organization and feed their greed, but in doing this it only allows the wealthy elite to truly have a voice and have the freedom of speech. We will implement new rules allowing a maximum donation of \$50 per person. No corporations or companies will be permitted to donate to any political party as they are not the voice of the American people.

The Robin Hood Revolution will next require that every federally elected official, including the entire justice system, which would include judges, the executive, the legislative, and judicial branches to all be fired. All our current officials and politicians have been tainted by the wealthy elite and thusly are corrupted and working against the everyday American citizen.

Next, we seek to eliminate gerrymandering which has been the driving force in manipulation of voting in territories across our nation. Additionally, we seek to eliminate the Electoral College, in doing this we are truly giving the voice back to the people. When our country was formed it was set up in a manner with representatives from every area of the United States of America. Our politicians came together to be heard, but with modern technology, this is no longer required.

In taking these steps we can ensure that every voice is heard equally, and in using a new pure democracy system we can accomplish that.

After this system is in place, we will use new senators, congressmen, and executive branch leaders to manage the new platform and run the pure democracy system. When an issue arises, these newly elected officials will be used to review new bills, provide the voters with analysis, and provide the voter with the pros and cons of all bills. Bills will no longer have attachments at the very end. We must stop backroom deals as everything needs to be transparently laid out so that all Americans can see and understand what they are voting for. Once a new bill has been proposed, a simple test will be administered to ensure the voter has the ability and understanding of the bill and understands what the vote means. The political leaders will be tasked with writing and producing the test for understanding.

The Department of Defense will be tasked with setting up the pure democracy voting software. If an American citizen does not have access to a digital platform, the post office system will be a physical location they can submit their votes at, or their local postal worker will be equipped with the means needed to help people vote along their delivery paths. In every vote, the majority

wins. People will vote on issues as it pertains to them. This means that if a vote is needed in a city, everybody within the city votes, if a county requires a vote then everybody in the county votes, if a state vote is needed then everyone in the state votes, and if there is a national vote then everybody in the nation votes. On the national level, by using this system we are eliminating favoritism and manipulation which politicians have been able to do through the Electoral College system. We are creating a system where every voice is heard and putting the power back into the American people where it belongs. These changes allow for each voice to be heard and real freedom of speech.

The other side of freedom of speech is being able to say what you feel and what changes you think need to be made. However, as you have the right to freedom of speech, you also have the duty to have empathy, compassion, and to treat others the way you want to be treated. Therefore, we cannot allow individuals or corporations to bully, attack, pressure, or force any other facet that would take somebody else's freedom of speech. Just as we have the right to speak, we also must make sure that we are doing so responsibly. Laws are already in place to protect citizens from harassment and other forms of bullying. However, with the legal system being so underfunded, many times, this issue gets swept away by too many other pressing issues. By getting proper funding from the wealthy elite, the people can ensure the police and other authorities become more productive in tracking these issues and prosecuting those who are causing harm.

Societal Rights

Age of Responsibility

“We the people of the Robin Hood Revolution hereby outline an issue that immediately needs resolving by holding a pure democracy vote to address the issue of age of responsibility. Our country requires you to be 18 years of age to join the military, you could potentially go to war to fight and die for your country. Furthermore, at 18 years of age, you can work in the adult sex industry, apply for credit cards, and student loans which allow the next generation of people to commit themselves to decades of liabilities. Even worst still, you can commit a crime and be tried as an adult at even younger ages than 18. However, we are acting in a state of hypocrisy by not allowing these people to purchase tobacco products, marijuana, or alcohol because the government feels they are not responsible enough. This has always been an issue that needs to be resolved, as you are treated as an adult in one respect and a child in the other. This comes back to racism discrimination, as many other issues do, but this is one of the most direct hypocritical laws in our government.”

SUMMARY:

- One age across all platforms needs established deeming a person a legal adult

FULL RESOLUTION: The interim executive branch board can handle outlining the pros and cons of what age you become an actual legal citizen of the United States. We do not feel it is the Robin Hood Revolutions place to say what that legal age should be. We need an outline of the

pros and cons and submit it for a pure democracy vote where the majority wins on this issue. We need to define one standard for all industries and states to declare the next generation as an adult and they are to be held by that standard across the board. It is not fair and hypocritical to expect you to die for your country, if you are not mature enough to drink, you are not mature enough to commit to dying for your country. Regarding the financial debt issues, they are fraudulent against these people which is why immediate action must be taken, and these are deemed fraudulent contracts. THESE AGREEMENTS NEED TO BE NULL AND VOID.

Environment

“We the people find that the wealthy elite has caused such a strain on our globe, for profit, that we find ourselves in a state of dyer crisis. The world we live in today has seen the explosion of plastic which hinders the natural life of our planet. The greed of the wealthy elite has caused pain and suffering to countless people and wildlife through the practices of drilling for resources, mining for resources, and using our oceans as a dumping ground. The pollution of our planet by the wealthy elite will long stand after they pass and our children will be left with a trashed, fragile world that will continue to spin out of control until we no longer have an adequate planet to live on. Although the technology exists to help this planet, the suppression of technology and continued practices of mining, drilling, and dumping have continued and accelerated for short term profits to make more money for the wealthy elite. These practices will continue so long as technology can be suppressed by the wealthy elite.”

SUMMARY:

- Set 10-year timeframes for food sustainability plans
- Reduction of coal mining practices and convert workers into a clean, green energy sector
- Establish new clean goals for the automobile industry
- Strict implementation of carbon credit program and 10-year window for all industries to comply, pay fines or dismantle

FULL RESOLUTION: The Robin Hood Revolution holds the environment very sacred; it affects every aspect of our life. The interim executive branch will place a panel of nine people who will donate their time to oversee the environmental reform for the United States of America. We set aggressive goals that every American will have sustainable green energy, access to sustainable food, free and clear of NGOs, preservatives, and plastic, and staple foods such as rice, wheat, barley, oats, poultry, and fish, required for a healthy diet. These will be produced within a 90-mile radius of where you live, and we need to accomplish this within a 10-year window.

We do support the global trade of food, we understand a global economy is needed, but we do not feel that our foundational food systems should be operated around the globe. Our food supply becomes susceptible from pandemics, foreign and domestic markets control the prices of shipping, amongst many other factors when food is globally transferred.

The food industry in America has been monopolized by five companies/families, this can change with modern technology. The technology exists to grow food in greenhouses using aquaponics

and other technologies. Furthermore, these foods can be grown without chemicals, manipulation of genes, and without abusing and treating animals with cruelty. We can develop a self-sustaining system that produces its own fertilization, uses its own watering system, and uses techniques that allow us to reuse water, so we are not impacting the global water supply. As part of our self-sustaining system, local greenhouses will have production contracts with local farmers and ranchers to provide beef, pork, milk, and other farm and ranch-based goods as these are items that the greenhouses cannot produce. All foods grown for society's consumption must have a zero-carbon footprint, including, but not limited to, harvesting, planting, fuel, and machinery. Pesticides will no longer be used.

Each greenhouse will be operated as a Co-op by members of the local community and will utilize personal time or pay fees to cover the necessary staff needed to maintain the food systems. In taking these actions we remove variables from the cost of foods like transportation and fuel. We can still trade with foreign countries, different states, and different communities within the country, but we need to produce the main staple foods for a society.

We need to set goals of altering the automotive industry away from gasoline-based vehicles within 10 years. Vehicles need to be made with electricity and batteries, or new technologies, but we must make this change to protect the environment. There will always be car fanatics who love their vintage and classic vehicles and there should always be gas for them to drive those vehicles they love and enjoy, however, we feel it is important to prevent the building of more issues caused by cars that produce more carbon when we have other means, technologies, and capabilities available to us.

Every community needs to provide a way, no matter the cost, to process its trash in an environmentally friendly manner. We have to hold ourselves accountable for the global plastic pandemic, and as a planet find a global approach to cleanup, by collecting all of the waste, trash, and anything that causes our planet harm in an effective manner that leaves a zero carbon footprint on the environment. Additionally, we will incorporate a carbon credits program which requires corporations producing any carbon footprint or pollution into the environment, to pay for these wrongs through carbon credits. This will launch a new industry within the United States, that will produce and clean air, ground, and water, and only require the corporations that are polluting the earth, to pay for expenses required to offset the footprint they are leaving from their pollution. All industry sectors will be required to present a list to the Environmental Protection Agency, outlining what action steps they will take to be completely carbon and pollution-free within 10 years.

Industrial sectors like the coal mining industry, need to plan to wrap-up production and close within 10 years. The hard-working Americans currently working there, who would lose employment, such as coal miners, would be the first available for hire in the new environmentally free industries. The people who retain these jobs will have higher-paying jobs, health insurance, and pension replacement if pensions are lost. We must take care of the people who have provided us with energy for all these years.

We move, to not only take care of the existing national parks and protect them from any more environmental damage, but we also want to expand them by injecting more finances into maintaining and preserving this beautiful planet. We feel that it is very important for the board to examine protecting all species on the earth to prevent further species from becoming extinct and maintaining life as it should be.

In summary, we want within 10 years from the date of this document, for our country to be completely self-sustaining in all aspects of food, water, waste, and protection of all aspects of our natural resources and species. There are too many practices that are being done now which are harmful to the environment and the people on earth, and if a company cannot convert its practices within this 10-year timeframe and commit to becoming sustainable in an environmentally friendly format, they don't need to be in business any longer.

There are many facets to this environmental policy of which the board, once selected, will have to organize an actual strategic plan on how to implement that plan in the country and then present it to the people to vote on as a pure democracy vote.

Inequality

“We the people are operating in a system that enables systematic dysfunction for anyone outside of extreme wealth. In any culture, in any religion, it is preached that those who have, are to take care of those who have not. In our society, the wealthy elite and corrupt politicians are acting in the exact opposite manner. The people with the most money, most highly educated and most gifted are called upon to pass along knowledge and teach those who need it most. Instead, the wealthy elite and corrupt politicians have used their status to be predators on those who cannot defend themselves through the buying of political leaders and abusing that power. The wealthy elite and corrupt politicians have allowed the American people to crumble by their ‘pay to play practices.’ Over time, these corrupt parties have gained more control, eliminated the middle class, and created a civil war between the wealthy elite and the poor.”

“The wealthy elite have used their status, power, control, and finances to force their voice and leverage their power over the innocence of our women and children and have repeatedly fought to suppress their messages of abuse to save themselves and continue with their practices. These ghastly instances have been allowed and supported by the corrupt politicians allowing for the vile and unspeakable acts to continue against the most innocent and vulnerable in our society and we cannot stand idly by and let these acts continue.”

“We also find that these same wealthy elite and corrupt politicians have used their status, money, and control to regulate people of all backgrounds. These people have suppressed men and women, people of color, people of various sexual persuasions, immigrants, the native people, every ethnic background and socio-status has been victimized and suppressed by these people.”

SUMMARY:

- The financial disparity between the wealthy elite and low tax brackets have only continued to grow
- A one-time equality tax of the wealthy elite of 40% collected over a 5-year window gives America an opportunity for stabilization
- This one-time tax allows America to build back the middle class which is pivotal to the sustainability of the nation

FULL RESOLUTION: To fix the financial inequality in this country, throughout this entire document, we have implemented an equality tax to people over \$500 million, as these parties have used loopholes and manipulation to avoid tax. A flat tax will ensure all people are paying equal taxes going forward. Healthcare for all ensures all Americans have free healthcare, the living wage needs bumped to \$25/hour to battle the inflation that people have been forced to comply with without getting fair wage increases. The banking reform will keep the dollars locally and force banks to loan into the small business of American which feeds the economy, reforming the Social Security and SBA to work together and stimulate local business. The food co-ops will allow people to have adequate and healthy food for minimal time and resources spent. The housing programs give a roof over the head of everyone, which gives people living in poverty a chance to rise to the middle class. This flat tax also ensures social programs will remain existing. Through the flat tax and the wealthy elite paying their fair share of tax going forward, we can maintain the essential capitalistic environment in America that has allowed us to achieve greatness in certain areas and allow all humans equal opportunity based on their abilities, not on race, sex, sexual preference, age or any other man-made faction.

Immigration

“We the people know this country was built as a melting pot to accept people from all backgrounds and nationalities, we were all immigrants to this country at one time or another. The people who aspire to come to this nation are doing so for a new start, a new hope. The laws which we have devised in this country are too stringent and take too much time for people to become a citizen of this country. We have national resources which are devised and equipped with the tools needed to check the backgrounds of people before they ever step foot in this country, and yet we allow our differences to dictate who can go in or out. We allow our differences to place a stranglehold on that hope. What happened to love your neighbor as yourself, as a country built on the idea of good, we are drastically falling short. These people are pursuing happiness and are doing whatever it takes to make it work in this country for a shot and instead we treat them as second class citizens because their families were not established here early in the development of this country. We are treating these people disgraceful in placing them in detention centers and isolating them from their families and their children. These people are not all criminals as much as the government and the wealthy elite would like you to think, they are simply looking for an opportunity to thrive, to support their families, and looking for a better way of life. We need a clearly defined path for these people to become citizens as most of the immigrants have done more for this country than the wealthy elites.”

SUMMARY:

- We have no answer here due to lack of credible sourcing and lack of knowledge
- We would like to see a streamlined immigration program
- We would propose an immigration tax on newly immigrated families for a 10-year window which would be used to roll back some of the national debt
- This can be justified by the fact we have all paid taxes in this country since birth, so we are asking for a small tax for streamlining your citizenship

FULL RESOLUTION: We are unfamiliar and under-educated in how these programs work and operate, furthermore the information presented by the government is contradicting and we have nothing to build off. Therefore, we feel it would be an injustice to make recommendations to these programs without the use of a proper board of people who have worked intimately for these people and in this system. We cannot fix a system where the information is tainted and misconstrued and therefore we need the true American workers, who act as boots on the ground, to use their voice in telling us the reality of these programs and what changes that can be made which will help these individuals in the most positive and impactful manner. Once ideas have been vetted for realism, assembled, and presented with pros and cons, then the nation needs to vote on how to move forward on this topic.

Justice System

“We the people are living in a time where the original amendment stands true, but the corruption of our justice system and the way people have abused it is unconstitutional. While the wealthy elite can use monies, relationships, and blackmail to keep them out of harm's way, that same statement cannot be made for all Americans. We live in a society that allows for the color of our skin to dictate whether we are guilty before we enter a courtroom and once in that courtroom, they are more susceptible to punishment for longer periods for the same crimes as their counterparts. We live in a time where we cannot afford to use adequate lawyers and are forced to use public servants who are not afforded enough time or resources to adequately help its accused. We are forced to fend for ourselves as the wealthy elite win on both fronts in bypassing courtrooms and bypassing taxes which would allow for more adequate and fair defenders to have full funding and time resources to help those who cannot fund themselves. We claim to live in the greatest country in the world, but the only thing we lead this world in is incarcerating people, some of which never belonged, and allowing the wealthy elite to corrupt that system as they control the food, goods, and have even built systems as a means to create more wealth. Additionally, our system has failed our security and police force as they are inadequately trained and underfunded by the choices of the wealthy elite. Our law enforcement officers are put into daily positions without proper training, under qualified and under vetted, as we are not doing our due diligence in looking into the people who apply, and under-equipped as a direct result of this tax evasion, and as a result, put the American people in direct harm. Many officers are being victimized, just as the American people, who are faced with dealing with members of the force, who are undertrained. This justice system has systematically failed the American people in every way possible and a revamp of the entire system is needed immediately”

SUMMARY:

- Blanket reforms from the federal government level down to city level
- Adjust sentencing guidelines
- Release non-violent marijuana-related criminals
- Review all cases to ensure justice is being served
- Eliminate all private prisons
- Police reform of funding and background checks

FULL RESOLUTION: The justice system is corrupt at all levels. It is controlled by the wealthy elite and when those wealthy elite get in trouble, it gets swept under the rug, not by the actual police officers or the investigators, but by the district attorneys and by the people in the highest levels of the government. A point in case is the Jeffrey Epstein file, it is obvious what a billionaire's money can do to avoid prosecution for hideous and predatorial crimes against children. Therefore, we must eliminate the justice system and start over with the entire reform starting with the federal government down to the state and city governments. We need to adjust federal sentencing guidelines that are too harsh. We need to modernize the laws to make sure that people are being treated fairly and we need to stop projecting onto people of color, because these individuals are being treated unfair and unjustly receiving significantly more confinement time than a white counterpart. We cannot have a justice system ran by the media. We cannot have a justice system ran by the wealthy elites.

We propose placing a board who solely works on reforming the entire justice system. We want to start by releasing all marijuana-related crimes that were non-violent and reviewing every single case that cast an element of doubt which needs to be questioned. We need to review cases and protect the freedoms of those individuals who have been convicted and verify whether they are guilty and that they are serving a sentence that coincides with the crime they committed.

Additionally, we find that government officials are willingly doing backroom deals with the wealthy elite, they are being held to a different standard, and thusly allowed to get out of crimes, quicker, easier, or all together. We want to remain respectful of the founding father's wishes regarding double jeopardy. Regarding the 5th amendment and all other amendments that stand for the people, modern politicians have manipulated these laws in the direction of the wealthy elite. We need to hold all people accountable for laws that have been broken, even those which have been covered up. The Robin Hood Revolution proposes that once these cases have been reviewed by the new justice system, they will review the sentencing for each person. We need to review the corruption in instances like the Rodney King case. The police officers, in this case, were guilty beyond a reasonable doubt, however, they were cleared by nothing other than the color of their skin, this is unjust.

We need to eliminate all private prisons, which have been placed by the wealthy elite, who receive investments from judges, treating people as a form of monetary gain, instead of the rehabilitation that these systems are designed for. All private prisons must close immediately

never to reopen. The government needs to be responsible for its prison system and they need to run them under the terms and understanding of rehabilitation.

Regarding the death penalty, federal sentencing guidelines, and state guidelines, we task the elected board to reorganize and reform this aspect of justice system. They will outline the reasons why they believe these guidelines should be changed and in what manner they need to be changed. Once this has happened it will be decided by the people according to their vote on whether they agree or not.

Every police shooting of any persons, regardless of race, is to be reviewed and a new court case needs to be established. This is going to be very expensive and could take a lot of time, but justice is a pillar which this country was built on and we need to stay true to that ideology. Police reform is going to be at the forefront of the Robin Hood Revolution. The first step is to give the police proper funding, not by firing the entire police force and starting over. We would advise the committee that every law enforcement officer receive a thorough background, pass a mental psychology test to ensure they are qualified to help every American and pass a physical test, which would qualify these individuals for these pivotal positions in communities across this country. As a part of this program, each candidate will need to pass a more strenuous training program, not just training on physical fitness or physical techniques, but on how to deal with people that have addictions, people that are intoxicated, and techniques for dealing with domestic abuse and dealing with family issues. In making these changes, we can alter the perception of police from being the enemy of the people to be the heroes on the front lines in their community. Each officer will be equipped with a body camera and a car camera, which is recording their entire shift. There will be no option to switch off their body or car camera. All cameras recording will be available as a live feed to be viewed by the people. If any law enforcement officer covers up the camera on either their chest or car, this party needs to automatically be suspended without pay. Their reinstatement will be deemed through an investigation committee at every station or law enforcement center. If it is decided that the action was taken involuntarily, there will be pay credited back and this party will be reinstated without any liabilities attached to them. However, if it is found that this action was done voluntarily, not only will this party be fired without pay and lose their pension, they will also be charged with the crime of obstruction of justice. In the event, there is a concern about classification which could impact other crimes or law enforcement from apprehending criminals, then the video may be classified for a predetermined amount of time, once adequate time has lapsed or the case has concluded, the American people will be given access to the footage. If an officer is involved in a shooting, killing, or hurting anyone, the footage cannot be classified. It must be available for the people to view through the police department's websites.

With each law enforcement center, local, county, state, and federal levels, a review board will be put together to review the actions of police brutality and actions of misconduct. A pure democracy vote will determine whether the officer retains their position with the law enforcement center or if they incur criminal charges.

Our law enforcement has been underfunded for years, they have been treated as second rate citizens from many American citizens and we need to change our view of these people. We need to be looking up to them as people who are building up our communities. We need to equip the officers with supplies that allow them to lend a helping hand, instead of only representing negativity.

Prison Reform

“We the people with the Robin Hood Revolution hereby declare the prison reform system has failed and continue to fail on many levels. Currently, one of the only things that the United States of America leads this planet in is having the most prisoners per capita. This system was originally designed to send people to the prison system for rehabilitation, through supplying programs, education, and providing a support system that would help the individuals incarcerated become contributing members of society. Although that was the intent when designed, the system has become based on punishment. Unfortunately, when people are sentenced to incarceration, many times they exit their time served as more educated in criminal activities. Furthermore, the likeliness of returning to prison and being incarcerated again is extremely high in the United States. As outlined in other topics, the justice system needs a complete reform starting by releasing 20% of the prison population that were non-violent, non-predatorial, and marijuana-related crimes. The minimal sentencing guidelines through the courts have become excessive and cruel.”

“The prison systems are underfunded, overpopulated and due to these issues, the programs are getting fewer resources and the population is getting higher. Corruption is running rampant in the prison system and the governments operating the prison systems are being controlled by the wealthy elite by building private prison systems that are operated solely for profit. A prime example is the phone systems that are run by wealthy elites and the individuals incarcerated and their loved ones are those paying for these calls. They are being taken advantage of due to the price point being so far above any market standard for telecommunications.”

“Additionally, the overpopulation has strained the resources of the guards and enables gangs, violence, and manipulation to run the prison system from internally. Once an individual is arrested and incarcerated, the United States becomes responsible for the cost of the court and the cost to incarcerate. Furthermore, the costs of removing an income earner from a family often leave families on the welfare system or in social programs because they cannot afford to maintain their lifestyle on their own and thus puts more strain on the system. There are ways these issues can be overcome but not with the system operating as it is, and with people making large sums of money from these operations, no real change to happen.”

SUMMARY:

- Close all private prisons immediately, reduce solitary to no more than 48-hour confinement, eliminate contracts with current food and telecommunication who make it too costly for families to contact each other
- Release 20% of current non-violent offenders, non-violent marijuana offenders and white-collar crime with case management and stringent supervision
- New program to fully legalize marijuana and use prison system to grow products, along with greenhouse foods, allowing for a reasonable wage to be made for their families and other costs accrued from going to prison
- Each prisoner is given case management to determine what their true issues are which ended with them in prison and convert prison to a true rehabilitation center, not a punishment facility

FULL RESOLUTION: The first step in reforming the prison system is to have the executive branch board select nine individuals that cannot profit off the reform of the prison system, to put together a plan which reorganizes the entire system, and this proposal will be put to a vote for approval from the pure democracy software and majority wins.

Items that must be included in this plan include creating a 48-hour maximum solitary confinement, closing all private prisons immediately, eliminating contracts with the telecommunications and food companies within the system, and get prison systems back to rehabilitation, instead of punishment. The plan must include, under the new Prison Reform from the board, the release of 20% of the currently incarcerated population. The 20% must have the following to be candidates for release, non-violent offenders, non-predatorial offenders, non-violent marijuana offenders, financial white-collar crimes who will be supervised closely not to have access to banking, computers, or other technologies, and inmates that had over the top sentences due to race, sex, or any other faction. Furthermore, funded by the equality tax, we will build greenhouses, on prison grounds, to grow the food which will be utilized in prisons and the school systems and provide these peoples fresh, non-NGO products, grown under the labor of the prisoners.

The marijuana system would work as follows; a new federal law allowing all 50 states to sell marijuana and marijuana products legally under the following terms. First, marijuana and marijuana-products must be sold online through a website that the prisons operate. The federal government, by utilizing assets of the IRS which will no longer be needed, will develop an oversight program to audit and to make sure this program is running corruption-free. The prison system will be required to ship all products through the United States Postal Service, which will make the postal service self-sufficient and no longer running under a deficit. Any current marijuana businesses, which were opened under independent state laws, will be grandfathered in and will be eligible to operate under the same standards which they currently operate. These growers are already operational, and we feel it is not the government's place to put them out of business. However, there will be no new permits allowed to open new stores under this privatized market. We, at the Robin Hood Revolution, are the utmost supporters of a capitalistic

market and we feel this is the only industry, which is just starting, that we could utilize to balance out the government's deficit and minimalizing the impact to the least amount of people, but we remind you that all parties will have to make sacrifices for this to come to fruition. In this program, the prisoners will be paid \$10 per hour to work, with 12-hour workdays, six days a week. From this earned income, the prisoners will keep all of their income after court cost have been paid for their prosecution, arresting law enforcement costs have been paid (these costs must cap at a certain percentage determined by the board), monies are sent home to keep families off welfare, child support is paid and brought current on any children they bore. Once those duties have been fulfilled, 20% of what remains may be used in the commissary system and the remaining is held in savings for upon release. This industry will help give prisoners purpose, drive, and develop a work ethic that will be pivotal upon release. We feel this will be a \$65 billion industry which will make the prison system stand on its own without the injection of more federal dollars, all while supplying goods and resources to the American people. States and counties will have expenses that remain for their jail systems, however, by reducing the other expenses and by getting paid back court costs, this should assist in offsetting former costs. This amount will be unknown until the system is in full effect.

Each prisoner will have a case manager, that helps identify all issues of the prisoner, helping them to get into a healthy state, whether from physical or mental issues. Additionally, these case managers will assist in creating education, family, and financial plans, and goals for the prisoners. Upon being released from prison, it gives the prisoners a direction to follow that will keep them from returning to the issues that incarcerated them. This process is completely about rehabilitation and redirecting one's life to project a better future for themselves and the families that they have impacted.

Racism and Hate Crimes

“We the people of the Robin Hood Revolution hereby denounce any sort of racism projected onto any group of people in a violent or harassing manner. When the constitution was written, the founding fathers prided themselves in using the following statements, “We the people, all created equal, and in the eyes of God,” which was hypocritical and a lie. Many of our founding fathers had slaves, they were racist and committed hate crimes against women and different minority groups. Today we can, unfortunately, add people's sexual preference to this list. As the justice reform system is outlining and reviewing sentencing guidelines, it needs to consider all racist and hate crimes which must be dealt with swiftly and prosecuted to the extent the law requires. This does not mean that they lose their rights of innocent until proven guilty as that is too a foundational piece in our justice system.”

SUMMARY:

- All people are equal, no matter what man-made faction people try to impose on another

FULL RESOLUTION: There is only one simple answer to this and that is all people are created equal before the eyes of God. There is no exception to the rule, but we feel that we need to outline further so there is no misinterpretation. Nobody should ever be looked at different in the

eyes of our government or treated differently due to race, age, sex, or belonging to the LGBTQ community, all people have the same rights to vote, live and take advantage of all rights without discrimination. If people cannot respect this, this is a hate crime.

Speedy Trial

“We the people find there to be no such thing as a speedy trial as many cases are drug out over multiple years. This simply happens as there is not adequate funding, and should our wealthy elite ever be taxed in a just manner, it would allow for our court systems to facilitate cases promptly.”

SUMMARY:

- Modernize the court system to have a speedy trial
- The system is understaffed which is partially to blame for cases lingering for long periods

FULL RESOLUTION: Laws are already established and have been since the beginning of our country's existence. However, these laws have been manipulated and the right to a speedy trial is sometimes put on the backburner. Very seldom is it done for the benefit of the court system, this is a case where the system is understaffed, in addition to being inefficient as the government is set in its old ways of processing people. We need to modernize the entire processing system while maintaining the laws and making sure the laws we have are being respected. The resolution to this issue will be headed up by a board selected by the interim executive branch of the United States.

Governmental Rights

Elected Officials (Campaign Reform)

“We the people find that this country is being run by corrupt politicians who have been bought before ever reaching office. These officials are sell-outs who are bought by the wealthy elite. There is no fathomable way for someone who works in our current system to come in with modest wealth and leave as millionaires without the aid of corruption from the wealthy elite. These people are paid pawns by the wealthy elite to do the wealthy elites dirty work and fraudulently pass laws and procedures on their behalf. Additionally, we find that these people lack all transparency and make daily moves which cost the American people, only to benefit the wealthy elite. The donations that elected officials receive from Super PACs and private donors display the stranglehold these people have on the politicians and dictate the direction of this country. For the work, the politicians do for these wealthy elite, they are given an abundance of money and healthcare that supersedes that of the true American hero's in our military veterans. The work of these politicians is far less admirable than that of any military personal and yet they are the ones forced to deal with unbearable VA standards. Our elected officials are nothing more than sellout puppets for the wealthy elite and are treated like something important. We cannot allow for these people to take advantage of the system any longer and shaming our military personal into healthcare which they themselves would not receive.”

SUMMARY:

- Dismantle the electoral college and use pure democracy vote through software
- Restrict donation limits to \$50, an achievable amount that any donor can make
- Make the use of Super PACs and their resources illegal
- In matters such as going to war with a foreign nation, this must be voted on by the people
- Maintain a two-party system which will be used as an analytical source with pros and cons for the people, they will no longer be voting on behalf of the people

FULL RESOLUTION: We the Robin Hood Revolution recognize that the everyday American has had their freedom of speech suppressed by the wealthy elites, ensuring our voice is silenced and not equally heard. We move to make it immediately illegal for Super PACs to purchase or contribute to any campaign, or any cause as these are funded by a handful of extremely wealthy families or individuals encouraging corrupt political change in our country. They also do this with gerrymandering and trying to maneuver guidelines which were outlined for the Electoral College. We demand the dismantling of the Electoral College system, nullifying the relevancy gerrymandering. Furthermore, in making this move, the Super delegates and mega-donors will no longer have any platform to manipulate our voting system.

The Department of Defense will be required to develop an encrypted digital pure democracy that operates our democracy programs and financial systems so all Americans in the country will have an equal vote. This program allows for all people to have a voice in demographics relevant to them, meaning every vote is counted as one. If we are voting on a national topic, all Americans have an equal say. If the topic is regulated to a singular state, all residents residing there have a single vote for that issue. No person shall be able to vote in two communities, their main registered residence will act as their residence for voting on all topics and issues.

Moreover, we want to issue a \$50 maximum for political contribution for every political position up for election. This is a dollar amount that any American can get to support a candidate they truly believe in. The actions of Super PACs, gerrymandering, Electoral College, and super delegates have repeatedly taken the vote away from the everyday American and therefore magnifying their voice.

The board will oversee the election and campaign reforms which will be made up of nine people elected or selected by the executive branch interim leadership. They will outline the entire campaign reform, how it works, how the loading system works, and will provide, for approval by the American people, a system that can be voted on allowing for the majority to win.

Regarding war declaration, the executive branch will no longer have the authority to commit the country to war without the vote of the people. For our country to move forward in war, a case must be presented to the legislative branch and those legislatures will write their opinions. They will retain the right to react in emergencies.

We will be maintaining the two-party system. They will present analytical advice for the people and informing you of the pros and cons, and different options. They will also make suggestions for the topic in question, but every issue comes back to the American people for voting in a digital pure democracy vote where the majority always wins.

For those individuals who are not technically savvy enough to cast their votes, the postal service becomes a crucial part of our democracy. With postal workers going door to door, they will help guide people through the voting process by utilizing an electronic device. By doing this we do not penalize parties who do not have Internet capability due to financial setbacks or those who have never kept up with the technology of the times. Postal workers will work with those individuals to make sure that they understand what the vote pertains to, what their options are, what the elected officials have said or suggested, and help them cast their vote.

Also, it has been said that convicted felons or the mentally challenged do not have the right to vote. We at the Robin Hood Revolution feel that Americans who possess the mental capacity to understand what the vote means deserves the ability to cast their vote regardless of race, sex, sexual preference, criminal proceedings, felonies, or any other perceivable man-made faction.

Finally, with the rights a pure digital democracy offers, comes the duty to cast your vote. As we have seen throughout American history, people have not taken their right to vote seriously. They have not shown up and that must end as well. It is your duty to take the time, to stay educated, and to read the facts, so when the time comes to cast a vote, at any level, your voice is heard.

Free Trade

“We the people need to reopen a free trade system which allows for the everyday American to trade their goods without being forced into a system manipulated and controlled by the wealthy elite, and allowed to make a fair dollar for their goods. The wealthy elite has established a system based on control and demand which is so corrupt and advanced, that the everyday American cannot thrive in a system where all inputs are curbed for the benefit of the wealthy elite. We need to have the freedom to work in a free trade market that allows people to operate and maneuver in a manner for the everyday American to thrive and make decisions for themselves that allow for long-term success for themselves. The system is driven by the members of Wall Street who take items and force unnecessary fees so that all the middlemen along the way are taking cuts of the people's profits that should be incurred by those making the products, and instead, the products are gouging the people, by adding additional fees to ensure their maintained wealth and eliminating their freedom of trade. We need to eliminate the criminals of Wall Street out of the system, cut the middlemen out of the system, and re-open trade lines for all Americans.”

SUMMARY:

- Create new trade lines with foreign nations that are not tainted by corruption from wealthy elite or politicians
- Utilize the military for the liberation of countries and utilize trade of tangible goods from those nations

- Localize our food systems to keep out manipulation and fight against issues that arise from taking foreign edibles into America

FULL RESOLUTION: We the people of the Robin Hood Revolution hereby declare that free trade needs to have an accessible and acceptable way of trading our products for the small farmers, family farms, and even some of the small corporate farms. Our small businesses get wrapped up in political games, by the country's wealthy elite and the political leaders, and manipulated by the middlemen on Wall Street. We need to eliminate and localize our food trade in every state and country. We should not limit the trade routes which small businesses use, thusly forcing small parties to compete with the larger publicly traded companies in a way they cannot. We will require the interim executive branch board of the government to place a board for free trade and Wall Street. This will be run by nine individuals that receive no financial gain from this board. The board will look at what trade avenues can be opened to create relationships with countries. These trades will be based on tangible goods like food, medical supplies, and other goods. Once these trade lines are established with countries, after the American people have been taken care of, we will sell our products to them and create a relationship based on positive effects on the society, environment, and the people of that country. These efforts cannot and will not be influenced by Wall Street profits, wealthy elite profits, and political figures manipulating these trade systems to their benefit.

The board will also examine the different people involved in the financial service industry such as stockbrokers, hedge fund analysts, derivative analysts, and their value to the American people as these are the individuals who have been living high off the coattails of the everyday American laborers. These people use a lot of information that is not shared transparently, and they manipulate it so the people cannot understand it. This board will investigate and determine the true causes of why trade has become so politically influenced and how we get released from those liabilities. America has the resources to grow an abundance of tangible goods that can be traded freely with international markets, and currently, that is not happening.

We also plan on reforming the military and foreign relations to better serve people. In this, the military with volunteers only will be working with different countries to liberate and eliminate corruption from those countries, if we are invited to do so. We will need a plethora of food and tangible goods to trade with these governments. Once the free trade and Wall Street Reform board have put together a strategy to better serve the people in the economy they will present it through the elected officials, with pros and cons, and the American people will cast their vote and the majority will determine how we proceed.

Infrastructure

“We the people have been systematically told from every politician that they vow to help fix and mend the problems with the country's infrastructure and once in office those vows are hidden and ignored as they do not fit the agenda of the wealthy elite. Our country's roads, bridges, highways, interstates, dams, and civil infrastructure are all decaying and are to the point of being unsafe for use of the American people. We should be talking about implementing new

technologies and advanced clean energy, waste solutions, and reducing our carbon footprint and instead, we are putting band-aides on these issues due to lack of funding in our country and because the two-party system won't stop their fighting to find a solution. If the wealthy elite paid their fair share in tax, our infrastructure would be brought to current standards and focused on building a sustainable future for all our issues, but also sustainable foods, green energy, and sustainable telecommunications. We are now behind our national counterparts and without immediate and extreme change we will never catch up. Even the projects which have been done, between closed-door deals and bid rigging, have all been corrupted by the wealthy elite, this needs to be addressed before actual work is done. The politicians have allowed the laws to change in the direction of the wealthy elite to ensure the only people who make money are the wealthy elite at the safety of Americans.”

SUMMARY:

- Revamp our infrastructure from funding from the Equality Tax
- Create an energy-friendly system for issues
- Create new technologies for updated facilities, ways to breakdown nuclear power plants quickly and safely
- Local owned companies need to be used for all new developments to stimulate local economies

FULL RESOLUTION: The Robin Hood Revolution wants to solve the infrastructure decay and turn it into the country with the most advanced and new infrastructure available. This has been a pressing issue for years and it needs to be dealt with immediately. This deals not only with the road system and bridges, but also sewer treatment facilities, waterways, roads, energy, greenhouses, bridges, and power lines. A board of advisors named by the interim executive branch will investigate the highest priority needs and how to address them but under the parameters of making our country 100% energy sustainable, implementation of proper roads and infrastructure, proper civil infrastructure, modernized sewage, and water cleaning facilities, bridges that need updated or severe maintenance and find ways to breakdown all nuclear power plants.

A large portion of the equality tax will be budgeted to bring our infrastructure up to become the country with the most advanced sustainable carbon-free, environmentally friendly infrastructure system available.

Going forward, a maintenance budget will be established from the flat tax that money is set aside every year for the upcoming needs of maintaining or building onto our current infrastructure. Furthermore, when contracts are submitted for the work to accomplish over a 10-year cycle, they must use local contractors, local workers, and purchase local products. Any work that is taking place must be completed by suppliers and contractors within a 90-mile radius of the work. Furthermore, every contract submitted has full transparency to the American people of where every dollar was allocated and spent on each project.

Foreign Relations and Military

“We the people declare we need to make fundamental changes in how we orchestrate our business with foreign countries. As a country, we operate like pointing a gun at the head of other countries creating hostile, divisive, and confrontational relationships with foreign relations. We are at a point in our global history where we need to begin looking at global denuclearization as these weapons are coming to a point of degradation and are becoming so unstable, they will cause problems and harm to each nation. We need to begin negotiating with our foreign counterparts in a way that neither party feels the harm of a deficit. We need agreements that are good for all countries involved. We need a transparent system that we, as a planet, can globally work off of and feel empowered to make solid choices for our countries, rather than operating under terms set by the wealthy elite that cause factions and issues amongst global trading. We need to stop depending on foreign nations to supply us with assets that place us at a disadvantage. We need to quit borrowing money from foreign partners that push us further into national debt and place us in susceptible situations. We need to begin building relationships on the concept of helping each other. We share this globe and if we learn to respect each other and treat each other how we wish to be treated, we will find we are more alike than not. We need to operate with a helpful mind rather than out of fear. We need to stop the constant war because if there is war, there will be profits, this does not make war right or necessary other than filling the pockets of the wealthy elite. We must learn to stop using invisible boundaries to define us and fraction us from other nations. We need to stop the mass-producing of war and instead end war.”

“We the people find that while we spend more than any other country on military supplies and equipment, it does not make us the greatest military force in the world. We try to pride ourselves on being the greatest, but being the biggest spender only benefits the wealthy elite and feeds the propaganda machine propped up by our corrupt politicians. We continue to operate under the understanding that we will go to war with tanks and outdated fighter jets like in the wars before our time, but no longer do we fight in this manner and the resources we have created go to waste and are sold to the highest bidder in third world nations to attempt to recoup spent resources. Nearly a third of our nation’s military equipment assets cannot be used and are purely used for show. Our corrupt politicians, under the direction of the wealthy elite, have no accountability for the monies they spend on these outdated and useless resources. We are in a fragile military state where we have no account of what resources we have, and this allows for corruption to run rampant as we cover up our abilities and hide our true resources. Additionally, we have some of the most recognizable special forces around this globe and these American heroes are operating with dated equipment that has been used for decades, that are unreliable and not safe putting these national gems in unnecessary harm’s way.”

“We the people further find that our American military personnel have been treated unjust and discarded. They have been afforded healthcare that none of our corrupt politicians are willing to use and yet they are the heroes that have risked their lives for this nation. The paperwork and application process to get medical help, mental health and benefit programs are purposely made too complicated or funds are unavailable, to ensure our national heroes do not receive this help. They have been tossed aside and treated like nothing as they risked everything for the American

people including the corrupt politicians and wealthy elites, who show no regard for the harm they have unnecessarily placed them in. Our leaders are so willing to place American lives at stake and go to war to create more money for politicians and the wealthy elite, and at unnecessary costs. Our politicians and the wealthy elite, pass by our military personnel who now live on the street and show no remorse for their lack of living conditions and the detriment which they have placed them in. We as the people cannot allow our heroes to be treated in the same manner which the politicians and the wealthy elite have allowed them to live in. We must help those who chose to help us first.”

“We the people find it unjust and a waste of our military resources to have committees which are there to serve the purpose of advising and directing our military resources to the executive branches of our government only to see these recommendations fall upon deaf ears. The corrupt politicians and the wealthy elite, are unwilling to follow the leadership of men who have guided our American soldiers through battle, and instead, follow the recommendations of political strategists who rely on polling numbers.”

“WE THE PEOPLE MUST STAND BEHIND OUR TRUE AMERICAN NATIONAL TREASURES, OUR SOLDIERS AND VETERANS OF THE ARMED FORCES.”

SUMMARY:

- End war profiteering by eliminating propaganda and allowing people to vote on when to go to war
- Reform the mindset of what a military is versus what it should be
- Focus on liberating countries in exchange for goods

FULL RESOLUTION: We at the Robin Hood Revolution recognize that war profiteering has been the backbone for numerous wars the United States has entered because of corrupt politicians and the wealthy elites. The profits from these wars have been made due to propaganda and bold-faced lies to the American people to convince us that we need to enter these wars resulting in the killing of millions of Americans. As our government makes these bold-faced claims that we have the largest military in the world and we spend more than most other countries combined, again this is propaganda pushed onto the American people by the government and at the service of defense contractors.

More than 60% of the equipment that our military has in stock is not in operating condition. The bulk of our fighter jets, ground assets, and even troops are not equipped to the standards they should be for tactical fighting thus meaning that these profiteers and politicians have immensely fallen short. The loss of morale by our troops is at an all-time low and is only declining as our current administration is calling troops to go on domestic soil.

The Joint Chiefs need to outline a military reform, as they are the people with the most knowledge of our military operations and can give legitimacy to what our military branches need today. The military assets that we hold today in stock would not fare well against our main

adversaries and against the technologies those other countries have developed as of now. Supersonic jets, among many other smart weapons, deem even our aircraft carriers and most of our Navy inadequate, as it has no protection against these jets.

However, in less developed countries like Venezuela, our military assets, if they were an operating condition, would be more than adequate to use in military exercises such as liberating Venezuela. Venezuela, for example, has more resources when it comes to oil than most other countries, but the political environment is too unstable for global companies to operate there. What is happening in this country is inhumane and goes against the core of what America stands for.

We are proposing a change to our state of mind as to what a military does. Our plan is to offer, the freely, elected government officials in Venezuela, our services from a voluntary only military, utilizing the assets that are inadequate to go against our adversaries in any real war and to use the United States military to help the people of Venezuela have their own pure democracy. We would enter a contract allowing the United States to have natural resources to be given to the United States government and the military in exchange for offering military assistance in accomplishing their liberation.

The United States of America has ineffectively tried to be the world police, always trying to foot the bill ourselves. In exchange for offering military assistance, it has traditionally fallen short and left the countries nationals in chaos with an incomplete government in disarray and often anarchy. With minimal investments, we could mobilize a small force, at the direction of our Joint Chiefs, and liberate countries, building partnerships with these countries, and ensuring they are operated by the people and for the people. We would offer this with no outside influence from America in their politics other than giving each of them the rights every human should have and giving them the assets needed which they can pay for once the new government is implemented. Not only should America be reimbursed for troop costs, weapons, and military assets but also the time spent by strategic commands, the Joint Chiefs, and any other expenses we have and can bill with transparency to the government. They would repay any accrued debt by selling us natural resources which we are currently buying from other parts of the world. Once they have their own operating pure democracy government, we would enter into trade agreements that neither country would have a trade deficit.

Things that we will build our relationship on are items such as medicine, medical technology, food, balanced trade, and working towards denuclearizing our world planet. We will try liberating these countries into a pure democracy, not by force, but by giving them the tools needed for training and educating their people to operate their own country and be contributing members to a global economy towards global peace. We use Venezuela as an example, but this same system would work in most countries that need help across the world.

National Debt

“We the people of the Robin Hood Revolution realize we have more debt than any other country on this globe and are spending in an immature and radical fashion only creating greater harm and susceptibility to our nation. We have surpassed 20 consecutive quarters of debt.”

“As a country, we have surpassed more than \$26 trillion in national debt which gives us a Federal debt to gross domestic product ratio of more than 130%.”

“We have a consumer debt, which doesn’t include social programs and other subsidy programs, of nearly \$14 trillion in items such as credit cards, auto loans, student debt, and homes. Specifically, we have more than \$1.1 trillion in credit card debt, \$1.3 trillion in auto loans, 1.5 trillion in student loan debt, and \$9.4 trillion in home debts. With all factors accounted for, the average consumer debt per person is more than \$43,000. If you add this to the total government debt of approximately \$80,000 per person, this country is in debt for more than \$123,000 per person in consumer debt alone.”

“These startling facts are only made worse if you take into consideration that 40% of our population is debt-free, meaning only 60% of this country carries this astronomical debt.”

“Above all, we have created a dependency in our country through some of our world's top adversaries in Russia and China, who currently carry part of these debts. This is critical to understand if we go to war with them, we are financially unable to keep up in every regard. The national debt has officially become our nation's top security issue as both these countries carry virtually no debts and the debts which they do carry, they have more than enough assets to wipe away these debts easily.”

SUMMARY:

- No solution, but this is an imminent threat to our national security
- Create a board to begin assembling options to tackle this problem

FULL RESOLUTION: At this time, we have no resolution, our economy is going to spiral, and it will be impacted. In fact, some of the issues we outlined in this document will cause further debt through the disruption of certain markets. With this being said, we will not cause the country to assume more debt at the hands of foreign nations. We feel the measures we have outlined in this document are necessary measures that must be taken by every American citizen to start a climb out of dependency. We deem it necessary that the interim executive board take time to consider our actions and determine which option, or options, we have as a nation to correct the issues at hand in regards to the national debt and ultimately national security.

Post Office

“We the people find the post office to be a foundational piece of our country. It is a fundamental right to have a communication method, and while there are similar ways and methods of communication, these too have issues. We must protect the post office and all its physical locations. As it stands, this operation is run completely and utterly incorrect, it needs reforming to make it a profitable asset and not a drain causing a fiscal deficit yearly. The post office is a necessary landmark for this country now and as it moves forward it can continue to be utilized by the American people, not in its current format, but as we make changes, it can be utilized as an asset.”

SUMMARY:

- Immediate changes such as closing on Saturday’s, all federal organizations must use for shipping and assist in the voting process
- Postal carriers will need to be educated on how the new voting platform works and part of those duties will be to help those who struggle with technology, work through the voting process

FULL RESOLUTION: In reviewing the budgets and expenditures of the United States Postal Service, several glaring items stood out from the information available. First, there is no reason for the post office to be open on Saturdays and we call to eliminate all work taking place on Saturdays. Second, all federal government organizations must use the U.S.P.S. for all shipping needs. This would include all federal marijuana sales and marijuana-related companies, which by itself, would make the postal service self-sufficient. Furthermore, the postal system would be required to assist in the voting system outlined in the voting section and collect votes from those who are not technologically advanced or lack the understanding of the technology used. Postal workers will physically go to their doors with a device to collect their votes. These workers will be educated on the topics, but more importantly will help explain the process of casting their vote and assist them in casting their votes as needed.

Taxes

“We the people find the tax system to be corrupt and inadequate. The wealthy elite, continue to manipulate the tax system allowing them to get out of paying the tax which is required of them by utilizing loopholes to secure their fortunes while the everyday American is forced to carry the burden of financing the American government system. The system is too complicated and not spread out. The use of the IRS is unnecessary, inefficient and outdated as the progress of technology would allow for the same work to be done without the influence of humans as they target the poor, the people who pay taxes, rather than the rich who evade it highlighting another benefit the wealthy elite claim over the everyday citizen. The national debt, which continues to grow, has swollen as the wealthy elite has evaded their duty to this country and as a direct result of their choices we see the programs, which are designed to help the American people, slowly wither away as inadequate funding has burdened the system. ”

SUMMARY:

- Abolish the IRS and establish a flat tax which will tax all goods equally and leave no loopholes for the wealthy elite to evade those taxes
- Implement a one-time equality tax on all individuals with a net worth over \$500 million
- Marijuana and related products will be taxed at 35%, these monies will be used to stabilize the school systems, give raises to teachers, and implement better security for threatening scenarios

FULL RESOLUTION: The interim executive branch will need to place nine individuals as a board of the people to oversee the tax reform. They will be responsible for laying out and presenting options to the people for a pure democracy vote where the majority wins every time. We move to abolish the Internal Revenue Service and utilize those resources for new programs or inject into existing programs that are underfunded. Key IRS locations will be kept, as will the staff, to operate the new tax structure. This tax structure will be done with a unified software system as a sales tax or flat tax will be placed on every purchase, from both physical and cyber locations, transacted within the United States.

A universal real estate tax levy of 1.75% will be placed on all real estate owned and will be used solely for the infrastructure of our country.

There will be a one-time wealthy elite equality tax that will equate to 40% of the net worth of every individual that exceeds \$500 million. Anyone under the net worth of \$500 million will not be subject to this tax. According to our research, there are approximately 2,500 individuals throughout the United States who meet these criteria. The reason we have highlighted this group of people is that from our research in writing this platform, we found that, in most cases, no federal income tax or very minimal amount of taxes were paid by these individuals. We are trying to recoup what is lawfully the countries, many of our country's pivotal programs have been diluted because of underfunding, a direct result of these individuals not paying their fair share of tax. Through the research we have done we estimate these people to have a combined estimated value of nearly \$21 trillion, meaning a 40% equality tax would inject \$8.4 trillion into rebuilding this country that they have taken advantage of and mistreated. We will be able to obtain substantial information from their tax returns and company business documents, but the full extent of their wealth will undoubtedly be held in other forms and we will need to do further research to get the full picture.

By implementing a flat tax everyone will pay their fair share whenever they buy anything.

The only exception to this rule will be on marijuana and marijuana-related products as it is a new industry. These products will carry a 35% education tax applied to every purchase made which will directly go to benefit the education system, schools, teachers, and security to protect our teachers and our future, the children.

Transparent Government

“We the people find that our government is acting without transparency and have been doing so with closed doors and back door deals, under the direction of the elite. Our leaders operate behind closed doors in a means to make changes for the wealthy elite and the resounding voice absent from the room is the American people. If the government is run, by the people for the people, then we should have access to all committees and other meetings in which they make decisions. Instead, the American people are having the door shut in their faces so that the wealthy elite can continue to operate behind closed doors under the protection of the corrupt government. The lack of transparency allows for the misappropriation of money and redirection of monies for the benefit of the wealthy elite. Our government is being advised and directed as though it is a modern-day mafia, leaving the everyday American without. We deserve to have transparency and they think in using the media they are doing so, but they are simply using media to redirect and misinform the American people. We have investigations in this country and yet the American people never see the findings as this too, under the direction of the wealthy elite, would draw back the drapes to the corruption that is happening. Until we operate with a truly transparent government, we will never have a politician or government that operates without conflict, we will never see real change.”

SUMMARY:

- D.O.D. will create the voting software which also gives transparency to government
- All meetings need to be recorded except for those which are highly classified matters
- Classification of files for decades is not needed, and accountability cannot be imposed in doing this
- All details of new laws must be presented before voting, eliminating last-minute backdoor deals, these details must be available through the transparency software

FULL RESOLUTION: We the people of the Robin Hood Revolution hear by require that our government be with the highest standards of transparency. As part of the software system that the Department of Defense would produce, it will also have a full transparency section of the software.

We no longer need to incur the price of our legislative branch traveling all over the world when technology easily allows them to have face to face meetings on the Internet.

No political meeting should ever take place that is not being recorded by the software. This software will record and be made available to the American people for every meeting, hearing, and committee discussion except for highly classified matters. The Department of Defense will allow for a short window of time, to protect assets and ongoing investigations. It is no longer acceptable to release these files decades in the future when they are no longer relevant, and people can no longer be held accountable for what actions they committed. No more backroom deals and handshake deals that take place behind the curtain of every negotiation or bill attachment. Going forward all details of laws must be disclosed ahead of time and it must be

easily accessible through our software system so that the American people can do their due diligence before they cast their digital pure democracy vote.

Politicians that wish to run for office must disclose five years of tax returns, a current balance sheet listing all of their tax assets, not just ranges of assets, and those assets must be held in a blind trust managed by a third party which reports to a person selected by the candidate. When a candidate wins the election, those assets must remain in a blind trust for five years after they leave office to ensure there are no financial gains. For far too long, we have had politicians elected with very small or no net worth and receiving a paycheck under \$200,000 a year. However, once out of office they have the net-worth of a multi-millionaire. This is corrupt and it can no longer happen.

There will be no financial benefit given of any book deals, politicians are not allowed to take anything that is monetarily beneficial to them until five years after the last day they have served in office. Furthermore, there will be no board deals allowing politicians to get paid large salaries, fees, or other financial gains until five years after they last left office. Then monthly statements must be released to the same transparency software of what their cash flow is, showing their income and expenses.

We also immediately require that all past and present publicly elected officials use the VA healthcare system until public health care is set up for all. Politicians will no longer get better health care than what the American veterans are afforded. Perhaps our VA healthcare system would be run in a better, more efficient format if the politicians understood the issues facing this system and there is no better way to understand these issues than to experience it themselves.

Finally, you are called to serve for your country, not create unlimited employment within the government ranks and therefore we are hereby saying that term limits must be implemented. No more than two terms can be served in any office nationwide, and for that term, they will only be paid the average household income for the district they live in. It is not fair for these individuals to become career politicians and coerce money and resources out of hardworking Americans. The government has become stale and in limiting terms, we can explore new ideas from new people coming into the government.

Voting

“We the people declare that we are working within a voting system that systematically silences the voice of the American people. We are working in a system that is based more on strategy, manipulation, gerrymandering, super delegates, Super Pacs, large donors, and finding the right states to talk to rather than talk to every American person. Our voting system of delegates is outdated and corrupt. We cannot continue to implement a system that takes away the voice of everyday citizens and allows people to sneak into office through manipulation of the process. The popular votes exist in any true democracy to show all American people where we stand as a collective and this vote has been silenced by politicians at the direction of the wealthy elite.”

SUMMARY:

- All current officials, elected or placed, must resign immediately with an interim executive board operating the country until the voting software can be implemented and laws have been reformed accordingly
- New candidates can apply for office, they will be required to release a specific set of information to run and represent public offices

FULL RESOLUTION: The Robin Hood Revolution voting system will work as follows. First, all elected officials and government placed officials must immediately resign leaving all federal government posts vacated. Next, the interim executive branch board will implement the new laws with campaign and finance reform programs that we have outlined in this document. This allows us to review all candidates that would like to run for office, their exact financial position, who their donors are, and that each donation made is by a citizen and not a company, eliminating company corruption or other methods of manipulation that have tainted the system in the past. Once the field of candidates has been established, they will release their platform via video submitting what office they are running for and what they represent. After reviewing each of the candidates, there will be a digital pure democracy vote and the candidate who receives the most votes will win the election.

From this point on, as issues arise, that formerly would be settled in backroom deals by corrupt politicians and the wealthy elites, now will be outlined by both parties, making their case with the pros and cons and no bill attachments added that are irrelevant to the bill. The board will create a small test submitted by the elected officials ensuring citizens understand the information and what they are voting for. At that point, people will cast their votes in the digital pure democracy program and the majority wins.

Dignity Rights

Education

“We the people find that the wealthy elite have failed the American people, but more importantly they have failed the children of tomorrow in blinding fashion. The wealthy elite have manipulated the tax system in such a way that our schools are severely underfunded causing a ricochet of events that only impact future generations. Their greed has ensured that our children eat preservative and plastic-based foods causing an obesity pandemic in this country. They have inadequately funded our security and police to the point where our kids are faced with the daily threat of not knowing how safe it is to go to school. We need a safe environment where our kids can be kids, be educated, and grow up with true hope for their future and the future of this country. They have disguised student loans in such a way that millions of unknowing teenagers apply for loans only to see continuous debt once they have graduated college. They have fraudulently hidden the truths of our nation's past and leave our kids with inadequate funding for new, accurate school materials. The lack of funding from the wealthy elite has left our nation's future trailing behind those of foreign countries as we cannot keep up, and consistently test

lower than other countries around the globe. Instead of funding more programs, we are cutting programs, cutting sports, cutting the arts, and forcing children into only a select few programs that are ensuring the benefit of the wealthy elite as they grow older and fit into molds the wealthy elite decide. The diversity in schools is being ripped away from our children daily. The heroes tasked with teaching our children are being underpaid to the point they work multiple jobs to stay afloat and they are the ones tasked with ensuring a bright future for our kids and this nation. The wealthy elite have killed the American dream through greed and through poisoning the future of our children. Our colleges and schools are being paid off by the wealthy elite as they control the research and manipulate the findings so they can control the message which they want to be presented.”

SUMMARY:

- Education should be a top priority and yet, we continue to slip yearly in global rankings because of inadequate funding to the systems and our teachers
- We must incorporate new technologies in the education system, update the foods they are given, increase the pay of our educators and reinvest into all the arts and other dismantled programs giving our kids, our future the most well-rounded opportunities available
- The legalization and implementation of the marijuana tax will accomplish the funding needed for this to happen and give enough for annual budgets to be maintained
- Modernize curriculum so they are being taught relevant topics to everyday living
- Implement more stringent rules against bullying and segregation

FULL RESOLUTION: The American education system used to lead the world; our country continues to slip further down the global rankings with no end to this freefall insight. The Robin Hood Revolution believes that the education of our youth must be the top priority of every community, state, and nation.

Several factors are dragging down the education system including lack of security, our parents live in terror now when their children go to school. The food we give the education system, the educators, and our youth are full of preservatives, full of pesticides, and in some cases, have traces of plastic. Education, in regards to curriculum and teaching methods, we can incorporate new technology and provide updated, accurate curriculum, because what we use now is outdated and often incorrect, we're not using the resources available to us to bolster the United States education system. Our teachers are paid embarrassing wages for what they do, and due to a lack of funding in the system, many teachers use the small wages they do receive to get their kids the resources they can afford out of pocket. Finally, many of our programs in arts and sports programs are being cut or reduced because of the lack of funding dealt to us as a direct result of the actions of corrupt politicians and the wealthy elite.

Luckily, unlike some of our other issues, there is a clear path to victory with fixing the education system which we will outline here. First, marijuana and marijuana products will be legalized and produced by the Department of Corrections and the prison systems. Systems will be set up and capitalized by the equality tax of the wealthy elite, then a 35% tax will be assessed on every

transaction that happens in the marijuana industry. The goods that come from the marijuana industry and its sales will be paid directly to our education system. We anticipate the marijuana industry to be a \$65 billion a year industry, an industry that some states are taken advantage of at this time. This will create an inflow of tax revenue to the education system between 22 to 26 billion dollars a year.

Also, we will set aside, from the equality tax, funds to update our curriculum and provide every student in the American education system with tablets equipped with curriculum needed for children from kindergarten through 12th grade. The state governments will still be required to pay the same amount but the federal government will not have to increase its spending as the 35% tax on a single industry will be everything needed to bring our education system up to respectability.

Additionally, the prison systems will also utilize greenhouses that will produce food, not only for the prison system, but also for the education system, hospitals, and senior living centers. This will provide all platforms with organic, fresh food without the use of pesticides and other harmful chemicals.

With the additional funding available every year, we can give every teacher a 20% pay increase, update curriculum, use electronic devices for that curriculum and hire local law enforcement to properly secure the education facilities to prevent mass shootings and petty crimes. This measure will also help keep drugs out of our schools. In doing these measures, we can bring dignity back to our teachers, the law enforcement securing these physical locations, and the students learning there.

The interim executive branch board will place an education board made up of nine individuals that will outline the exact details of this reform, finalize the financial forecasting, and set up the fiscal budgets so that we pay the teachers what they deserve to be paid. This allows us to provide opportunities to give our students a well-rounded education with access to extracurricular activities in sports programs, art programs, music programs, and all the other programs that are getting funding cut at this time. These programs better equip and better overall balance our students to enter society.

We will also begin teaching our students more common-sense driven courses like how to purchase a home, how to budget, and how to maintain a life today. Many youth and young adults have missed out on these pivotal stepping stones and they only will incur more problems in the future if we do not provide the necessary knowledge to help them accel not only in the classroom but in the everyday world.

We need to put more strenuous rules in place to hedge the bullying which is taking place in our schools. If students cannot feel safe, if they are focused on hiding from these bullies, or if they feel minimized by the social and economic surroundings around them, they will not be able to

focus on learning and progressing forward. We need to curb these issues to give our children an environment they can feel safe in.

Additionally, segregation and lack of funding allocated to schools based on color, income brackets, and geographical location will be omitted from this assistance. Every student despite age, race, sex, sexual preference, or any other faction that man has created, will have no impact on the economic commitment that the students, faculty, and facilities are given.

Once this has been researched and a strategic plan and fiscal budget have been implemented, it will be given to elected officials to fully outline the plan of implementation, the plan for funding, and be submitted to the country for a pure democracy vote, and the majority wins.

Food

“We the people find the food systems have been manipulated by the wealthy elite who have directly forced our political leaders into a system which leaves the American people in a state of degradation causing harm and dire health issues. They have manipulated, the integrity of food, from the form it was meant to be, and control the entire country through their deadly food choices. Additionally, they are putting the American people at risk from price gouging, and from manipulated government control of the hard-working farmers who are forced to work within a system that allows for the wealthy elite to have more financial gain. The goods they created and pushed for are encouraged by the government, knowing how deadly they are to the American people and are causing generations of reoccurring obesity and health issues.”

SUMMARY:

- Implement greenhouse systems that allow for all communities to grow fresh foods locally
- Implement contracts with local farmers, giving them proper funds for the good produced

FULL RESOLUTION: The interim executive branch board will have to set up a board with nine individuals to oversee this food process, all food and all cost associated which will be taken out of the equality tax. The Robin Hood Revolution proposes that all communities across the nation be afforded a federal grant, collected from the equality tax on the wealthy elites, which will be funded pro-rata to the number of citizens in the population. This allows each community to grow their fruits, vegetables, and many of their staple foods like rice, barley, wheat, poultry, and fish. These foods will be produced in greenhouses with the most advanced vertical farming, aquaponics, hydroponics, and greenhouse technology available. It will be set up as a Co-Op where each person or family would be required to put in a set number of hours to grow enough food to provide for them and their families. Their time commitments would also allow for the production of food to be distributed to the impoverished people of their community. All food must be grown within a 90-mile radius of the individuals unless it does not make sense based on geography, this would be decided by the board, who would also be tasked with determining what those boundaries are. For productions of beef, milk, lamb, and swine, as well as, corn, soybeans, and wheat, which are all growing in large fields, production contracts will be established with local farmers, cutting out all of the middlemen, and letting the local farmers thrive by feeding

their neighbors, the local people. If the greenhouses produce more food than what is needed to provide, not only for themselves, but also for the impoverished people in the community, the hospitals, and schools, we will package goods and go get the best price possible by selling these to other countries, communities or anywhere else that is in the market.

Healthcare

“We the people find that every person should have the right to fair and affordable healthcare treatment. We are kept in a state of oppression from the medical community pushing medicine at an unaffordable cost, at the cost of human life for the profiteering of the wealthy elite. The wealthy elite, through politicians, have used patents to keep affordable medicine from people and oppress the people through monopolization and price gouging. The corrupt lawyers are using loopholes to find clients that have caused such a strain on insurance companies that it impacts the care of life a doctor can afford its patient and has caused costs to be unsurmountable for the oppressed people of this country.”

SUMMARY:

- All people deserve free healthcare, ask Canada for assistance in creating a program so this can happen
- Identify and eliminate price gouging from the system which is driving up all costs
- Figure out how to blend all our current healthcare systems
- Terminate premium insurance for all senators, congressmen, and any elected officials, they will be required to use the VA for their health care until this program is in effect

FULL RESOLUTION: The Robin Hood Revolution feels that health care is not a privilege, but a human right. This goes back to the core of all religions, the core of all humanity, which is to love your neighbor as yourself. Currently, millions of Americans are going without health, dental, and vision care, and in the long term the problems that are not being dealt with now will end up costing the government more money. We propose to do a health care system for all, the number one health care system in the world today is Canada, our neighbors to the north, we should humble ourselves in asking for their assistance in revising our healthcare system, and model it after what they have established. We have no issue with private hospitals and private clinics which the wealthy elite can pay for if they feel like they will get superior service, but with technology today and influence from resources like Canada, we can build a health system second to none in the United States of America for all people. The United States government needs to look at what hospitals are charging, the price we pay for medicines, the cost to use medical equipment, and eliminate all price gouging. We also find it cruel and harmful to place patents on technology that is keeping healthcare from getting out to the masses of the people and thus want to eliminate all medical patents. We do not believe that any patent, on any technology, should overcome the rights of the people who need the medicine. We would ask that the interim executive branch board selects a board to help establish a healthcare system for all. These members will act on behalf of the American people and will operate this board with no financial gain and/or no favors owed to them. This board will establish the reform and how to get from our

current state to a health care system that every American is getting what they need for health, dental, and vision care.

Also, we have segregated a portion of our population and we need real health care for the mentally ill and especially for our veterans that have been left in despair. It will be the duty of this board to help figure out how to take current systems, such as the VA for the military, public hospitals, and private hospitals, and determine how we can mold these together in one unified system ensuring that all American's receive sufficient health care.

Immediately, we declare that all senators, congressmen, and any elected officials be required to use the VA for their health care until this program is in effect. There will no longer be premium services afforded for the elected officials over the veterans, our American heroes, who put their lives on the line for America. Once this board for the health care system has outlined different plans available, the American people will put it to a pure democracy vote. It will be explained to the people by these representatives and health care officials, then the people can vote to which they would like to see, the majority of the vote wins.

The people of this country have encountered additional strain through means of medical debt imposed on us by the medical industry and more directly the insurance and pharmaceutical industries. These outlandish and over-the-top fees must be eliminated and forgiven as the prices have been inflated for profiteering of these industries and they will never be able to recoup the losses as they live off the backs of the people.

Housing

“We the people find this country acting in irony, as we were a country built on “Christian” values and yet we have a large population of people living on the street. There is a disconnect in this country between our local, state, and federal governments, which is allowing for people to live on the street when we have homes, apartments, and motel buildings vacant and we cannot find a way to get homeless bodies into beds. We have a fundamental issue caused by corrupt politicians and the wealthy elite, which is holding us back from getting bodies into beds, and that issue is greed. We need an overhaul reform of the housing industry that abolishes the use of credit scores and other discriminatory factions, and instead, find ways to help people get a roof over their heads. Many of the issues surrounding homelessness are caused through mental illness and addictions and we treat these people like the plague. We cannot claim to be a great nation when thousands of people call the street their home. We have failed as a nation and if led by the corrupt politicians and the wealthy elite, we will continue to fail.”

SUMMARY:

- Hospitality venues will be required to save a percentage of their rooms for the homeless population
- Develop a housing association task force to get every American “head into a bed”

FULL RESOLUTION: A housing board will be placed from the interim executive branch board and will be made up of nine people. Their goal will be to get every homeless person into a home immediately as they develop a long-term solution for this problem.

Immediately, we will require hotels and motels to dedicate a percentage of their rooms at every location to be used for the homeless population. These rooms will be paid for at a rate based on a fair amount to the hotels and motels, but not at marketplace rent equivalency to that which they may lease rooms to customers. Again, we need to reinforce the concept that every American is going to have to contribute to overcoming the national issues we are facing in America, this includes the corporations in America.

There will be money set aside from the equality tax, placed on wealthy elites, and a program will be developed tasking this board through creating a housing association task force that will lease and pay for temporary housing allowing for each person to have a bed and a roof over their head. The government will subsidize those individual clients, whether they be individuals or corporations, making the priority “heads in beds.” The individuals staying in these programs will work with the social services and case managers to develop a long-term sustainability plan for each client regardless of health care problems, mental illnesses, experienced economic downturn, addictions, or any other issue they need to overcome. Additionally, we need to get people educated, allowing them opportunities to go into the field of their choice, and truly achieve long-term economic sustainability.

Social Security

“We the people feel that our social security program has been under threat from the wealthy elite and our political leaders from choosing to not pay their fair share in taxes. The social security system, which was designed to create retirement for all, has been bled dry by our politicians under the direction of the wealthy elite to maintain and keep their industry alive and thriving. These same businesses will never have the wherewithal to repay these debts and as a result, the social security that the everyday American once had is no more. This tragedy lies directly at the feet of our politicians and wealthy elite who have failed the people and have left them in a state of survival we cannot maintain. The deficit of this country has been borrowed from the social security fund, rather than the wealthy elite paying their portion, and instead of investing in the future for the people, the people will be robbed of their hard-earned monies.”

SUMMARY:

- Rebuild and reform the Social Security systems
- Reinvest into small business

FULL RESOLUTION: We the Robin Hood Revolution hereby commit to rebuilding and reforming the Social Security program. The Social Security program is owed trillions of dollars which our United States government has chosen to start borrowing from dating back to Lyndon Johnson’s presidential tenure. The interim executive branch will select nine committee members

to focus on Social Security reform and work with the board to correct the national debt reform, determine a plan to get the finances back where they belong, and re-establish the Social Security program as the people's money, not the governments.

These funds should be used to fund SBA loans for all entrepreneurs and small businesses. In adding an 8% rate of return participating in 50% of the risk. The term “small business” needs to be defined, but no company exceeding more than 100 employees should be considered a small business. These small businesses are what stimulates growth in this country and make up a vast majority of American’s jobs. The details and how this system would work will be outlined by the board and will be given to the American people with options and the pros and cons. This will lead to a pure democracy vote to take place to determine its fate.

Furthermore, we find the wealthy elite have been finding ways around paying Social Security for decades, we need to collect Social Security on every American employee, large or small.

Social Services

“We the people find that social assistance is a privilege, not to be abused, by lazy or unwilling citizens to work. We find that while there is need for a welfare, it is not a right, but rather a privilege, and it should not be taken lightly. These programs come under immense strain as they are not adequately funded as a direct result of tax evasion our wealthy elite have taken to bypass taxes and remain shielded by these corrupt politicians. When a member of society is reaching out for assistance, there should be a clear understanding that this help is being given in a loan format with a clear repayment method established for once these people are back on their feet. They need to be given the tools needed for success for themselves as well as their families. We need to have greater, more conclusive, and more efficient case management for these members of society to ensure they are not being placed in situations worse than what they came from. We feel that children should not be pawns used to defraud more money out of the government's system and if those adults are unwilling to abide by a repayment system and refuse to get adequate care than those children should be placed with people capable or willing to fulfill that call. We the people feel that adoption and foster care need to become more streamlined to ensure the children the best quality of life and so they are given the greatest opportunity for success going forward. This can only be accomplished through more efficient and proper vetting of people taking part in this system and eliminating those people from the program who use it as an income source.”

“As a society, it is our moral duty to take care of those who came before us, to help our elderly and mentally challenged and provide them with a standard of living which we would like to have someday.”

SUMMARY:

- We task the interim executive board with assembling a board with real knowledge of this issue to assemble a realistic plan to battle this issue
- We have an inadequate understanding of this topic

FULL RESOLUTION: We are unfamiliar and under-educated in how these programs work and operate, furthermore the information presented by the government is contradicting and we have nothing to build off. Therefore, we feel it would be an injustice to make recommendations to these programs without the use of a proper board of people who have worked intimately for these people and in this system. We cannot fix a system where the information is tainted and misconstrued and therefore we need the true American workers, who act as boots on the ground, to use their voice in telling us the reality of these programs and what changes that can be made which will impact the individuals in the most positive and impactful manner. Once ideas have been vetted for realism, assembled, and presented with pros and cons, then the nation needs to vote on how to move forward on this topic.

Financial Rights

Currency

“We the people of the Robin Hood Revolution understand why our country began using cash as the main monetary system, as it was built originally off the gold standard. However, the continued use of cash has created immense costs for the people as we continue to produce bills, maintain bills, and transport bills. Furthermore, the use of cash allows and creates far too many loopholes allowing people to evade taxes. If we eliminate cash and use a digital currency, we would immediately make it difficult to purchase illegal goods, and the immediate benefit would allow us to trend and track down traffickers of drugs and humans/children in the United States. In using a digital currency, you are not putting any more risk on the users, as most money is operated within banking systems and software, which most people use today. By allowing cash to be freely exchanged, we are exposing our country to the entire black market and allowing criminal empires to keep flourishing. Additionally, with taxes, if we eliminate the use of tangible currency and change to the digital, it will make tax fraud virtually impossible.”

SUMMARY:

- Eliminate paper money, go purely digital
- A full audit of the gold in this country, we base currency value off that amount

FULL RESOLUTION: The Robin Hood Revolution submits a plan, to the people to vote on, to use the same software that the Department of Defense is creating for the voting technology, utilizing a fingerprint biometrics system, amongst other ways to keep it secure, of which all technologies already exist today. All transfer digital funds would be made through the digital bank and a flat sales tax would be applied to every transaction at the time of purchase making the need for the IRS or other government organizations a thing of the past. Transactions can still happen from person to person, but through trending of cyber histories, it would be easy to highlight patterns of drug dealing and criminal empires business. We would implement this system and revert to the gold system, that our economy was originally based off.

The first step in this change would be to get a full audit of all of the actual gold, its purity, and the exact whereabouts of its location to show the people it exists and has not been used fraudulently. This would give validity and sustainability to our currency which is already coming into question by many countries.

Financial Establishments and Debts

“We the people find the financial platform to be corrupt and aimed at oppressing and squandering the hard work of the everyday citizen. The practice of financial establishments, enforced by the wealthy elite, has caused a strain on the American people financially to the point in which most cannot recover. Our country is run by four major banks and the fees which people endure from, and are forced to comply with make it unattainable to maintain a baseline lifestyle or thrive in. The credit industry has defrauded the American people by allowing them to enter into agreements they know the people cannot fulfill. The practices established through banks, credit, loans, student loans, cash advance establishments, and Wall Street, are enforcing the modern-day practices of slavery, not allowing for people a way to get out by keeping them suppressed by the wealthy elite for unsurmountable terms.”

SUMMARY:

- Dismantle all major banks and convert to a credit union format
- No banking outside of a 90-miles radius from where your primary housing is located
- Termination of all fees
- Abolish all student loans
- Stricter relations on loans for houses, cars, and cash advance establishments

FULL RESOLUTION: The interim board which operates the executive branch will also select individuals to form a financial reform board. This board will oversee the dismantling of all major banks and convert them to a credit union format. Once the financial institutions have been converted into the credit union format the account holders will pay the bank owners, over a 10-year timeframe, 85% of the profits made from those banks. After the 10-year window has passed, 15% minus any loan loss deductions will be given back to the original institution. Each bank will return to a brick and mortar format. We will eliminate institutions with a multiple branch concept, there will no longer be multiple branches as each location will stand alone and be owned by the members that hold loans and deposits at that institution.

No bank will be allowed to make loans to any person or corporation outside of a 90-mile radius of that physical location. Any loans will be redirected and established in banks within their 90-mile radius. The loans which carry bad debt will be paid back from the profits made at that branch over a 10-year period. Once this time has taken place, the account holders may vote to drop the rate, as any other credit union is operated. All housing and mortgage companies will be required to restructure their home loans to a 15-year amortization at a fixed rate of 4% and will not exceed 25% of homebuyer's income for the payment of the home, taxes, and insurance. If the loan amount is over 25% of the home buyer's income, the loan amount will be reduced until the payment fits within the 25% criteria.

The Robin Hood Revolution feels the American people, the education system, and students, both past and present have been defrauded by the education loan system. Student loan companies use political sway to protect themselves from bankruptcies. They have made promises to these young Americans about employment and opportunities only afforded to those who have attended post-high school education. They are bleeding money out of our American youth, who as a society we say are too immature to drink alcohol or smoke, yet they are sophisticated enough to enter into long-term debt that will haunt them for the next 30 years. All this debt will be completely forgiven and those financial institutions which made these loans will be at a total loss, as there will be no repayment ever.

Financial institutions will no longer be able to charge Checking Account Fees, Minimum Balance Fees, Overdraft Fees, Extended Overdraft Fees, Returned Deposit Fees, Hard Copy Paper Statement Fees, Account Statement Copy Fees, Returned Mail Fees, ATM Fees, Out-Of-Network ATM Fees, International ATM Withdrawals, Excess Activity Fees, Online Bill Pay Fees, ACH Bank Transfer Fee, Wire Transfer Fee, Cashier's Check Fee, Teller Fees, Cash Deposit Fees, Investigation Fees, Foreign Transaction Charges, Lost Card Fees, Inactivity and Escheatment Fees, Account Closing Fees, NSF Fees, Maintenance Fees, Stop Payment Fees, Check Image Service Fees, Transaction Search Fees, Investment Fees, and all other fees these con-artists try to impose on the American people. These practices are comparable to loan sharking, if not from a financial institution. All banks must reimburse the last 24 months' worth of all fraudulent fees to the people, as this was a fraudulent practice and the banks were taking hard-earned monies from the people who could least afford to lose it.

Credit card companies will be required to inherit a similar reform to that of the housing reform. Credit cards cannot exceed more than 5% of your total overall gross household income. The interest rate will be set at 5%, if the amount of these credit cards total exceeds the 5% household income, then these companies will have to write the debt off. No matter what the write-off is for any loan, it will not be issued as a tax liability.

Cash advance companies are at the heart of this corruption as they are preying on individuals that need help the most. They are taking advantage of people by inventing fees and other clever loopholes to charge hardworking Americans astronomical fees. These companies will no longer be eligible to operate in this manner. If they choose to loan to individuals as a pay cash advance, they cannot exceed a 7% interest rate in a 12-month repayment cycle. They will be held accountable, like the credit card companies, to not loan more than 5% of that household income.

Automobile loans will be offered through various entities and will do so at a seven-year amortization maximum. If the automobile is more than two years old, it will be a five-year amortization maximum. The maximum interest rate that can be implemented is 6% and the maximum payment not to exceed 5% of the household income with the payment alone, not including automobile insurance.

All financial institutions and credit card companies will need to have a salary cap so that the wages earned from the lowest position on staff to the highest level have a disparity of no more than 400% difference.

One of the most relevant examples of the corruption in this industry, although there are many, is large banks like Wells Fargo that have manipulated their clients out of billions of dollars in transactional fees and NSF fees. Wall Street allowed and aided in covering up these crimes as did their board of directors, and once the news went public not one party was charged with criminal crimes, no one was given jail time. Not only did no one serve time for the crimes they committed, but also, these bank officers were given multi-million-dollar payouts for retirement to walk away. To this day, no one has been held accountable for these actions, and the clients which they represent continue to be manipulated and stolen from. This can simply no longer take place.

Wall Street

“We the people feel that Wall Street is full of lazy, manipulative, and crooked individuals who work the system to benefit the wealthy elite and completely control the political parties leeching off the American people. These individuals, daily, find ways to manipulate the goods and services of this country to deplete any profits from the American people. The service they work in provides no tangible goods that can be applied to our GDP and they can do this through the puppeteering and control of the American political system. They have taken advantage of the people through multiple avenues and disguised it as something good, giving the people the illusion that good is being done on their behalf. They are using banks, as you must in this country, only to “fee” people into poverty. They offer consulting services to people in how to delegate their hard-earned monies, only to put it into a market where it can be sucked dry, leaving people without, and they are doing this without providing a single positive, tangible good to the economy and its market. Wall Street has sucked the middle class dry and this is purely illustrated as we see the desperation and unjust practices that are now taking place. We once were built as a nation that could operate with a single income family and happily have all our needs met, and a mere 50 years later we have to work four jobs just to be above the poverty line and yet still cannot survive. This injustice is felt by nearly every American and more are feeling this pressure every day as the wealthy elite thrive off our hard work and use the system to continue to suppress the people.”

SUMMARY:

- Operate off tangible goods, not made up services
- Eliminate any employments based off manipulation of fees, commissions, and other scandalous manipulations

FULL RESOLUTION: The free trade board will report back to the executive branch and the people of the United States. If you look over the history of our government, you will see the economy has been operated off tangible contributors. The service-oriented industry like Wall Street, contributes a very small percentage of the overall economic base. Currently, the service

base industry in the financial sector is a much higher percentage than tangible goods. This means we have a large population of people operating on the coattails of our everyday labor force including farming, manufacturing, construction, and almost every industrial sector. The market today is being bled by the way it is being utilized and hurting the individuals who have invested. The financial market has created a variety of investment opportunities through derivatives, hedge funds, mutual funds, retirement accounts, and commodities among several others, of which no actual value is brought to the actual good produced. There needs to be an entire Wall Street Reform that includes transparency of the transactions through pay scales for all these different service-oriented positions in the financial industry. If no value is brought to the actual goods produced, these roles need to be eliminated. Wall Street has found more ways to manipulate and increase values artificially through clever paperwork and clever ownership structures, by eliminating tax liabilities to themselves and bypassing those liabilities along to the everyday customer. Just like how major banks derive most of their profits from NSF fees and service fees, Wall Street makes most of its money from fees, not the actual interest of the money they helped establish for their clients. We expect a complete reform of the entire financial sector eliminating all employment that is based on the manipulation of service fees, sales commissions, and any other way people have figured out to scam the market and get back to the basics. This is going to create an immense amount of backlash as these individuals will not want to put in the hourly times required, the labor required to produce their income, or perform to provide for their own family. Once the board for the free trade and Wall Street has investigated these two areas, they then will provide options and restructuring that can take place to make these systems fully transparent so that the people have access to facts, that the investments are being audited, making sure there is no more fraud taking place, and then the people taking part in these criminal activities will not be forgiven without justice being served.

CALL TO ACTION:

We, as Americans, feel that change in this country is past due and we are choosing to make this call for change now, at a point in our nation's history when it has never been needed more. We are calling for this change behind closed doors as we are not idols, nor leaders and do not feel it is in the best interest to lead this movement but rather give the people a chance to make this change under the direction of true American leadership. For that reason, we are calling upon General Mark A. Milley, chairman of the Joint Chiefs, to act as the interim President of the United States of America and run the Executive Branch Board. This board will be diverse in people and their beliefs which will give a true voice to all demographics represented in the United States of America. We ask that the board be comprised of Americans from the following diverse backgrounds:

- Native American Representation
- LBGQ+ Representation
- African American Representation
- Military Representation
- Political Representation
- Hispanic Representation

- Samoan Representation
- Asian American Representation
- Scientific Representation
- Constitutional Lawyer Representation
- Activism Representation

We have assembled a list of people who we feel best fit the criteria to lead the Executive Branch Board. This Executive Branch Board will be tasked with assembling other boards to directly work with the issues laid out throughout this document.

The purpose of this board will be to create the changes which we have outlined and only implement them, at the approval of the American people, until the current system has been updated to allow every Americans voice to be heard. This board will bring guidance, diversity and needed change to the American system like never before.

We ask that for our part in creating this new American direction, we, our families and loved ones are given immunity for any present, past or pending legal matters that may have arisen in our journey to this point. We have chosen to remain anonymous to this point for the protection for families and loved ones, and upon completion of this plan, we will reveal our true identity.

We are calling on the American people to stand up against the unjust practices lead by the corrupt politicians at the direction of the wealthy elite, but in that call we are asking for peaceful, non-violent actions to be taken against these people and their properties. While they are corrupt, greed ridden people, they are people, and we would be no better than them if we were to take rash and unjust practices into our own hands. We wish to make this change in a productive manner that benefits nearly every American. As for being involved in this cause, should you wish to donate, we will accept up to a maximum of \$50 for this cause per person, just as we outlined in our political reform, and these funds will be relegated to uses for advertisement only.
